2. Minutes and Matters Arising

3. Finance

Finance Report

The balance on the account as of 28 December was £3467.74, This included a grant which had been received from Glasgow City Council which could not be accounted for. This matter was still being looked into.

OSCR

The outgoing treasurer of the Society confirmed that the Trustees Report and Annual Financial Statements had been lodged with OSCR in advance of the deadline of the 31 January 2013.

Easy Fundraising

It was noted that approximately £10 had been donated to the Strathbungo Society via the Easy Fundraising web site. A percentage of all purchases made via the website (which gives access to many other web sites) can be donated to the Strathbungo Society. An email was sent to those on the Strathbungo mailing list advising them of Easy Fundraising and encouraging them to sign up.

4. Communications

Newsletter

The Editor of the Strathbungo newsletter advised the meeting that the deadline for receiving articles for the spring issue of the newsletter would be the 24 March. The possibility of using pay pal to generate invoices and receive payments from potential advertisers to the newsletter was discussed. It was agreed to keep things as they were at present. However, Dee Miller was asked to discuss with new advertisers to see if this was something they were interested in using.

5. Upcoming Events

Bungo Art Competition

An update on the Bungo Art Competition was provided by Teresa Mooney. Work is well in hand for the art competition and downloadable entry forms and supporting information are to be placed on the BungoBlog. It was agreed that the theme of the competition be tweaked to People and Plants in Strathbungo to tie in with South Seeds and the year of Natural Scotland. Prizes will include art gallery tours with Avril Paton for older entrants and an art workshop downstairs at Tapa for younger entrants.

These included an information table, raffle, cake stall and whether our local animators would consider attending this year's event again.

Brighter Bungo

It was noted that the recent Brighter Bungo clean up had attracted 15 volunteers and many new faces despite the cold weather. It was agreed that a message be placed on the BungoBlog requesting a volunteer for the role of Neighbourhood Improvement Volunteer.

A meeting will be held in the next couple of weeks with said volunteers which will be advertised on the BungoBlog. A decision would be taken at the next monthly meeting on whether to hold BITBL this year based on the number of volunteers that can be found.

Cash Machine - Update
