1. <u>Sederunt and Apologies</u>

The Acting Chair welcomed all present to the meeting and advised that in the absence of the Chair and Treasurer she would be undertaking both roles at the AGM.

2. Approval of the Minutes for the AGM held on 23rd October 2012 and Matters Arising

The Minutes of the AGM held on the 23rd October 2013 were approved. No matters were arising. However the Acting Chair noted that the planning application for 23 Marywood Square had been refused and an appeal of this decision had also been declined.

3. Adoption of the Trustees Report and Annual Accounts

Financial report

The Treasurer outlined the independently audited accounts for the year 2012 –13. The full accounts are detailed in the Annual report, which will be available on the society website. At 30th April 2013, the Society held unrestricted funds of £2043, a surplus of £97 over the previous year.

The contents of the Trustees Report and Annual Accounts was received and noted. The Secretary was requested to lodge them with OSCR. Mr Allan Hunter was thanked for auditing the Trustees' Annual Report.

6. Open Discussion

- d. <u>Mission Hall</u> A brief discussion was held on the possibility of the Society developing a project for the Mission Hall in Nithsdale Road or whether the Society would object to potential development proposals for the site. It was noted that the Mission Hall was considered part of the Common Good of Glasgow. However, the Society expressed contentment at receiving any presentation from anyone wishing to use the site.

All present were thanked for their thoughts and comments which the Society will discuss further in its regular meetings over the comings months

7. Any Other Business

Cllr Norman MacLeod thanked the Society for inviting him to attend the AGM and made all present aware that as their elected representative he was available to his constituents via regular surgeries and the contact details on his flyer which he would distribute after the meeting. The Councillor also encouraged the Society to continue its good works and consider membership of the Southside Integration Network.

The Chair thanked the Councillor for his continued support to the Society and also noted the support that had been provided by both Councillor David Meikle and Bailie Hanif Raja over the year.
