2. Minutes and Matters Arising

Mineworkings

Stephen Lamb advised that he and the Chairperson had met with the Council and Forkers and that they had agreed that the Strathbungo Society would host a meeting to discuss the various options for the reinstatement of the back lanes after the mine consolidation works had been completed. Five options for reinstatement had been considered, but only the following options were considered feasible –

- Clean up and repair existing sets
- Remove existing sets and replace with new sets
- Tarmac and part repair existing sets

The Strathbungo Society stressed that it could not endorse any of the back lanes reinstatement options. However, it was happy to host a meeting so that these options could be discussed by those living adjacent to the back lanes to be reinstated. A letter was to be issued to these residents inviting them to a public meeting on the 20th February at Queens Park Church outlining the options available to them.

6. A.O.B

The Society was advised that a query had been received on the Society web site by a group of Belly Dancers wishing to attend Bungo in the Back Lanes. Joanna Murphy was to be advised of this request. It had been noted that enforcement action had been taken by Glasgow City Council against a resident in Strathbungo due to them installing upvc windows in a conservation area without consent. It was agreed that the Chairperson should write to Mr Frazer Macleod of DRS, Glasgow City Council to highlight the results of their own survey re the number of unacceptable windows in the Strathbungo Conservation area and to ask what action would be taken against other offenders.
