Bungo Birl – 23rd November 2013

Planning towards the fundraising ceilidh to be held on the 23rd November was progressing well. 16 adult ticket remained unsold with no family tickets remaining. 6. Planning

No new planning applications were presented. However, it was noted that the Titwood Road Resource Centre was to close in 2015 with Julie McDonald of GCC having responsibility for managing the closure and finding an alternative use for the building. Concerns were expressed as to what the alternative uses might be. Mark McDermott was meeting with Cllr David Meickle on the 22 October to discuss the closure. Mark McDermott was encouraged to meet with the other elected members also for the area and to report back to the Strathbungo Society.

7. Any Other Business

Pollokshields Area Committee

Nick Kempe updated the Strathbungo Society on what had been discussed at the September meeting. It was noted that information was to be provided about public services at the next PAC meeting and that concerns re street cleanliness in East Pollokshields had been expressed at the meeting.

The opportunity to discuss community safety services and the sexual assault which occurred in the area was taken with the Police representative present and about concerns re lighting in the back lanes with Land Services threatening to withdraw maintenance. The police representative at the PAC noted that they were not unduly concerned as notwithstanding the attack, the Strathbungo Area remains one of the safest areas to live in Glasgow (and therefore very low priority for cameras) but there may be the opportunity to use the PAC to facilitate discussion with Land Services on solutions to the lighting.

Area Councillors had demanded that an action plan for the area be presented at the next PAC meeting.

Licensing Laws

The Strathbungo Society was advised of residents' concerns re a loophole in the licensing laws that allows any pub to apply for seating outside a public house for a two week period and there after extend this request. No consultation or public notification was required for this. The Society agreed to look into the matter further and encouraged all with any information on these loopholes to update the Society.
