3. Minutes

Jane responded that the Strathbungo Society Committee has continued to pursue these with Network Rail this year.

Steve Good presented the accounts, noting the Society had a healthy surplus and net funds of £5,935 but that this was before activity was affected by Covid-19 and that income will be well down in the current financial year. He hoped that we could encourage more residents to become Friends of the Society. In response to questions: it was noted that Window Wanderland does not generate income, that the street entertainment related to this is grant-dependent and the Society had purchased its own lighting equipment to reduce costs in that area. He also noted that there was potential to use our Paypal account to make it easier for people to become a Friend.

The Annual Report and Accounts were then agreed unanimously.
